## **UCI COVID-19 MASK POLICY**



From the Director of UCI Campus Public Health Response Team, David Souleles:

Dear UCI Community,

As COVID-19 cases continue on a downward trend from earlier this summer, the Centers for Disease Control and Prevention (CDC) has moved Orange County from the high COVID-19 community level to the medium COVID-19 community level. As such, we are pleased to share that effective Saturday, August 20, 2022, the campus will be rescinding the executive directive on mandatory face coverings.

Face coverings will continue to be recommended indoors, but not required, regardless of vaccination status consistent with current <u>California Department</u> <u>of Public Health (CDPH)</u> guidance on the use of face masks in California. Therefore, individuals should feel free to continue to wear face coverings if they desire.

Per <u>CDPH guidance</u>, face coverings are still required in healthcare settings on campus including the Student Health Center, the Counseling Center, the Student Center COVID-19 Testing Site, as well as at UCI Health. Face coverings may also be required consistent with public health guidance for a limited duration for those who were COVID-19 positive and returning from isolation, and for those recently exposed to someone with COVID-19. <u>Face coverings continue to be available on campus</u> for students and employees.

While the indoor face covering requirement is being lifted, the campus will maintain a number of our prevention and surveillance efforts to help control the spread of COVID-19.

• OLLI at UCI will continue to provide face coverings to those that request one.
